



Risk Waiver

Please read carefully before signing as this document.

EXCLUSION OF LIABILITY - WAIVER OF RIGHT TO SUE - YOUR ASSUMPTION OF RISK

In consideration of JOYRIDE MTB COACHING ("JOYRIDE") accepting my participation in a coaching event which may involve a significant risk of physical harm, I agree to this release of claims, waiver of liability and my assumption of risk.

I am aware that mountain biking is a recreational activity which may involve, in addition to usual and inherent risks, personal injury, obvious risk, danger to myself, the possibility of injury and harm and physical exertion for which I may not be prepared, remoteness to normal medical service, weather extremes subject to sudden and unexpected change (including severe wind, falling trees & branches and other unforeseeable events), and evacuation difficulties if I am disabled.

I accept all of the inherent and obvious risks and that mountain biking is a dangerous recreational activity and the possibility of personal injury, death, property damage or loss resulting there from. I acknowledge that the enjoyment and excitement of mountain biking is derived in part from the inherent risks incurred by the activity beyond the accepted safety of life at home, school or work and that these inherent risks contribute to such enjoyment and excitement being a reason for my participation.

I hereby release and forever discharge from all liability and agree not to sue JOYRIDE and/or its officers, employees, volunteers, agents, contractors, public bodies, land holders and sponsors from any and all claims, suits, demands, expenses, costs, damages or proceedings of any nature whatsoever arising from any personal injury, death, property damage or loss sustained by me as a result of my participation in the event.

I hereby indemnify and hold harmless JOYRIDE, its officers, agents, contractors and sponsors from and against all claims, suits, demands, expenses, costs, actions and proceedings of any nature whatsoever arising from any injury, loss or damage sustained by me or any injury, loss or damage suffered by any other person as a result of any act, omission, neglect or default on my part in connection with my participation in a coaching event.

I agree that if I suffer injury JOYRIDE can at my cost arrange medical treatment and emergency evacuation services as JOYRIDE deem essential for my safety. I hereby agree that I am responsible for my own medical and ambulance insurance.

I agree to allow my photograph, video, multimedia, or film likeness to be used by JOYRIDE for the promotion of its business by the organisers, sponsors, or others.

Terms and Conditions

1. The participant is duly aware of the risks and hazards inherent upon entering the event locations and participating in events at these locations.
2. The participant acknowledges that they are physically and medically fit to be involved in the activity and will notify Joyride immediately their fitness or medical condition adversely changes.
3. The participant and/or their parents and/or guardians have taken into consideration any personal insurance cover they may require to ensure they are not at financial risk whatsoever from any possible injury or accident which could occur, while travelling to, from, or at the event.
4. The participant recognises that the locations may become more hazardous and dangerous during the time that the undersigned is present on the location riding his/her mountain bike on the location.
5. The participant recognises that falls and collisions with pedestrians, other mountain bike riders, trail users and vehicles do occur. The participant assumes all risks and responsibility for such incidents and injuries, including injury to others.
6. The participant understands that HELMETS ARE MANDATORY and agrees to wear an Australian Standard (AS/NZS 1698) helmet at all times.
7. The participant will only attend the event(s) with a sound and well maintained mountain bike, and will advise their coach immediately of any adverse changes to its performance which could cause risk to themselves or others.
8. The participant agrees to follow all instructions given by the coaches, and recognises that any behaviour which could put at risk any member of the group, including themselves, could result in IMMEDIATE cancellation of their course and expulsion from the event. Dangerous and/or disruptive behaviour which puts at risk other participants and /or coaches will not be tolerated.
9. This Waiver and the Terms and Conditions within it, lasts for the entire duration of your relationship with Joyride, in perpetuity.
